Global Evaluation

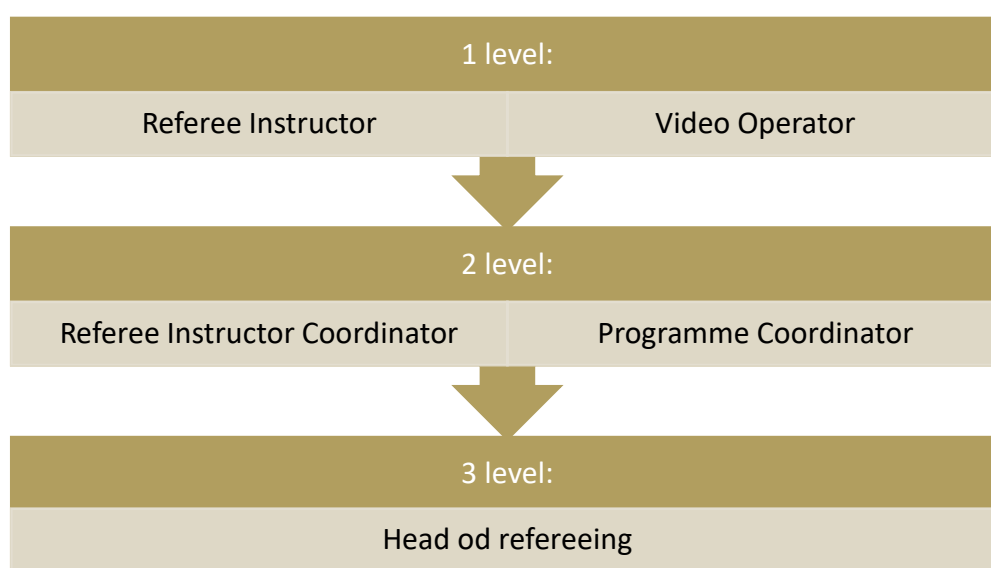

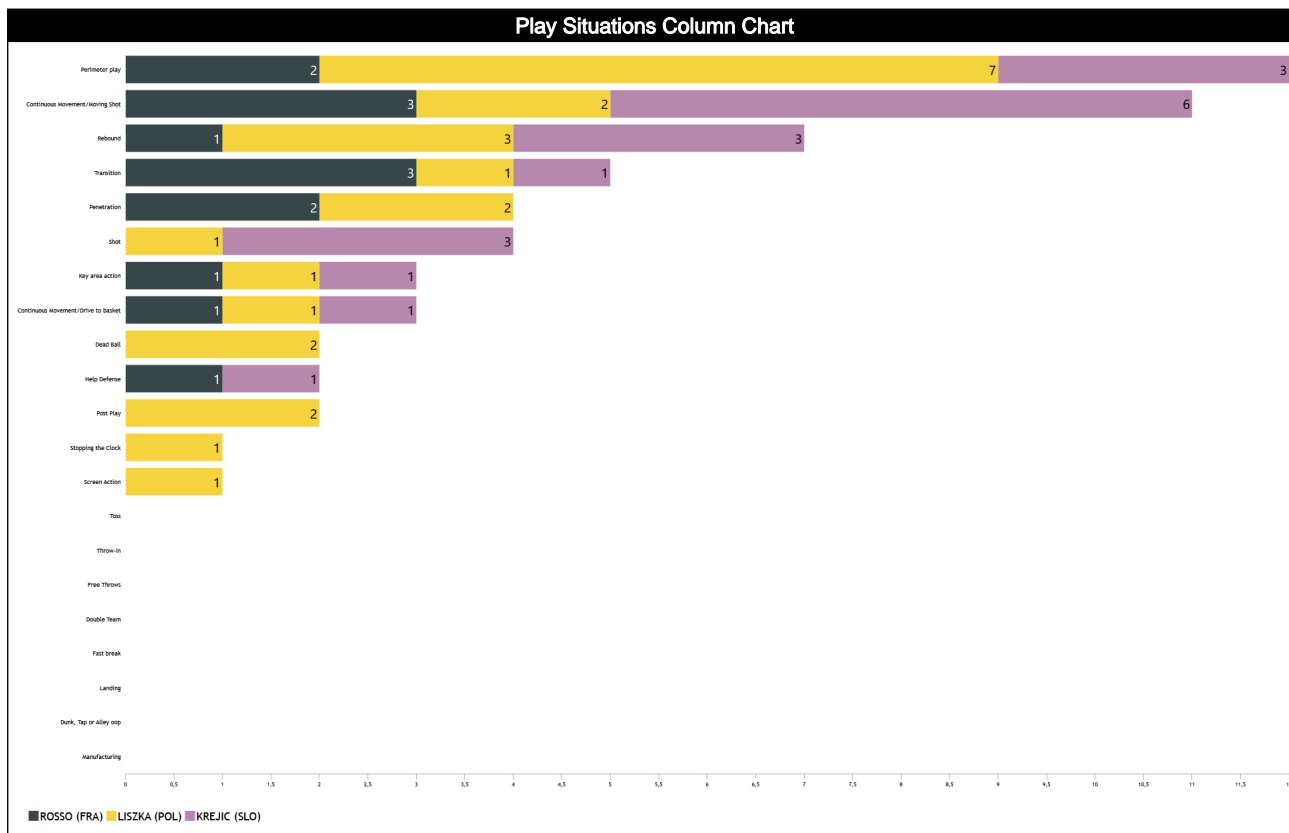
