Global Evaluation

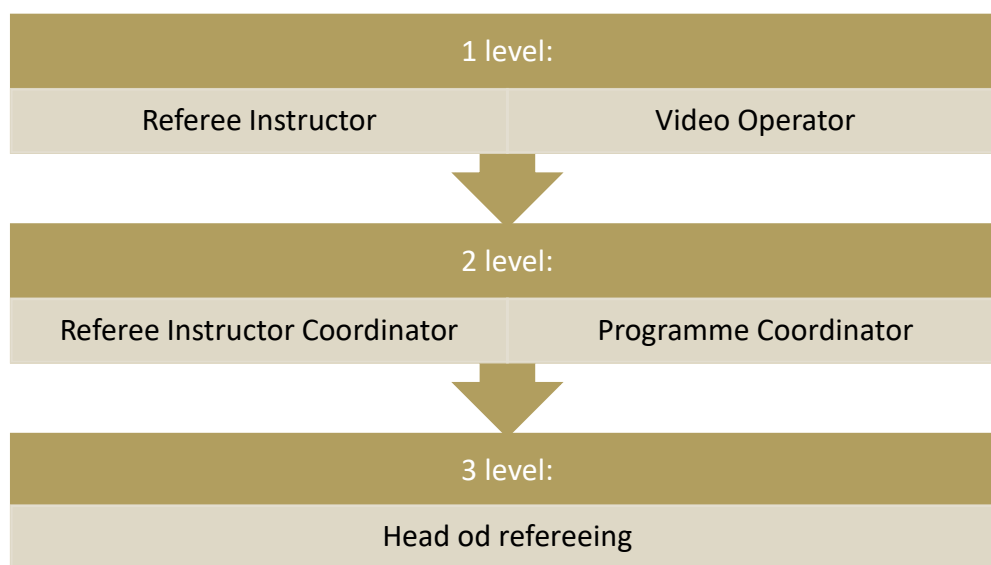
