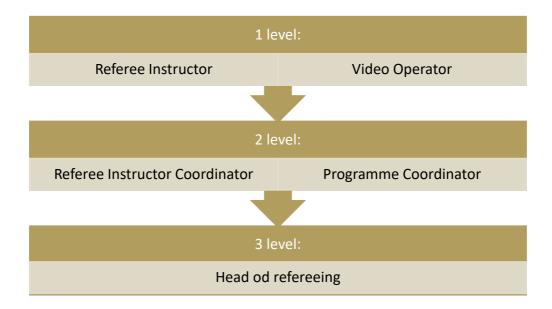
Most importantly, data can be used to:
